This summer will see the passing of the Anti-Social Behaviour, Crime & Policing Bill, which will fundamentally reform the remedies available to registered providers, and others, in dealing with ASB. For example, Anti-Social Behaviour Orders are to be abolished, ASB Injunctions will be replaced by Injunctions to Prevent Nuisance & Annoyance and mandatory grounds for possession will be introduced in certain cases.

This seminar - which is run in conjunction with the renowned Social Housing Team at Hardwicke Chambers - will explain the changes and their practical implications for private registered providers and each participant will be provided with a comprehensive pack setting out the reforms in detail.
